To Whom It May Concern:

Armacell, LLC manufactures several types of insulation foams at 5 manufacturing plants located in Mebane, NC, Conover, NC, Dallas, GA, Yukon, OK and Brampton, Canada. All Armacell's products are classified as "articles" according to Title 29 of the Code of Federal Regulations, OSHA Part 1910.1200©, page 463.

According to REACH the definition of "article" is as follows:

"Article means an object which during production is given a special shape, surface or design which determines its function to a greater degree than its chemical composition;" (REACH, Article 3(3))"

Articles as defined by REACH regulations are exempt from registration as long as they are not intended to release a chemical substance. To the best of our knowledge, all Armacell foam products meet the definition of "article" according to REACH.

In addition, to the best of our knowledge, the Armacell Insulation products listed above do not contain any substances of very high concern (SVHC) above the threshold limit included in the REACH SVHC list updated January 23, 2024.
